1. I will pay all balances due at the end of the sale, to be paid using a signed blank check.
2. I will not bid on any taxes on a parcel that I, or anyone I represent, have any interest.
3. I will not collude, bid rig, or conspire with other tax buyers or County employees.
4. I understand that only one bidder at any one time may bid per registration
5. Tax Certificates will be titled using the above listed registration information
